What information do we collect? Wellspring Settlement collects and stores the information you have provided on this form so you can become a legal member of the organisation. You are the data subject, Wellspring Settlement is the data controller.

What will we do with your information? Wellspring Settlement will use your information to keep a list of current legal members of the organisation. Your information will be held securely within Wellspring Settlement and will only be accessible to staff and certain volunteers. We will not share your data with any other organisations. We may use your data to report on our work to our Trustees, Bristol City Council and our funders. It will never be used in a way that can identify you. If we ever need to share your data with another organisation we will explicitly ask for your consent before doing so.

How secure is your information? We make every effort (by locking it away, keeping our computers safe and having a secure database) to ensure that your personal information is held safely and to stop other people being able to see it.

How long will we keep your information? Your data will be kept according to the retention schedule set out in our Data Protection Policy, which allows for your data to be retained for 1 year from the expiration of your membership.

Access to your information and correction - your rights. As a data subject, you have a number of rights. You can:

- access and obtain a copy of your data on request;
- require Wellspring Settlement to change incorrect or incomplete data;
- require Wellspring Settlement to delete or stop processing your data, for example where the data is no longer necessary for the purposes of processing; and
- object to the processing of your data where the Wellspring Settlement is relying on its legitimate interests as the legal ground for processing.
